

# HOLSTON ARMY AMMUNITION PLANT

## 2017 FISHING APPLICATION

1. Holston Army Ammunition Plant (HSAAP) is providing the opportunity for the general public to fish the restricted section of the Holston River within the installation's boundaries once again in 2017. HSAAP's public fishing program was approved by the HSAAP Commander under a strict set of guidelines designed to insure that safety and security standards are maintained while each fishing event is being held. Individuals interested in fishing on HSAAP must apply for the opportunity and will be selected by a random drawing. Depending upon the number of applicants, there will be three or four fishing events held on HSAAP this year, the dates of which, are indicated below. **Important Note:** The fourth event scheduled for Sunday, July 2 will be cancelled if there are fewer than 58 total applicants for all of this year's events.

2. The following guidelines will be implemented during each event. All fishing will be done by wading and no boats will be allowed during any event. This will be a catch-and-release program and participants will not be allowed to keep any fish they catch. Participants will not be allowed to use live bait such as minnows, crayfish, etc. Each participant will be required to bring, and wear, an approved life jacket at all times while fishing. On the morning of each event, participants will be assigned specific sections of the river in which they may fish and will be monitored at all times by installation personnel. The quota for each event will be 16 participants. Participants will have approximately 7 hours to fish during each event. HSAAP reserves the right to cancel a fishing event if unforeseen factors arise or installation personnel determine that water conditions or forecasted weather events, etc. are unsafe. If a fishing event is cancelled, it will NOT be rescheduled.

3. Eligible participants must be at least 16 years of age (at the time of the event) and all participants must possess valid Tennessee fishing licenses as required by state law. Minors (17 years and younger) must apply, and fish with, an adult who is 21 years old, or older, during any fishing event. Due to the way in which fishing areas will be assigned, applicants are strongly encouraged to apply in a group of two. However, applicants may also apply individually. Applicants may not apply in groups consisting of more than two people. When applying as a group, both applicants must request the same dates.

4. To apply, complete the form below and send it with the appropriate application fee to: Holston Army Ammunition Plant, Attn: Fishing Program, 4509 West Stone Drive, Kingsport, Tennessee 37660. Applicants should include a \$4 nonrefundable application fee per person with their application. The application fee must be paid with a Money Order or Cashiers Check made payable to: U. S. Treasury. Applicants who submit personal checks or cash will be disqualified and forfeit their application fee. Applicants who submit more than one application will be disqualified. If selected, applicants will be required to purchase a HSAAP fishing permit for \$20 at a later date. All applications must be RECEIVED at HSAAP by June 1, 2017 to be considered in the drawing. All applications must be mailed in!! Applicants will NOT be allowed to drop off their applications at the front gate with Security personnel or have them hand-delivered to the natural resources office by employees in order to meet the application deadline!! Successful applicants will be notified by mail by June 10, 2017 and will receive specific information about their event at that time. Unsuccessful applicants will not be notified by mail.
